

That if subsequently any defect is found in ownership. Any other documents or any encroachment will found, owner/developer shall be liable for the same.



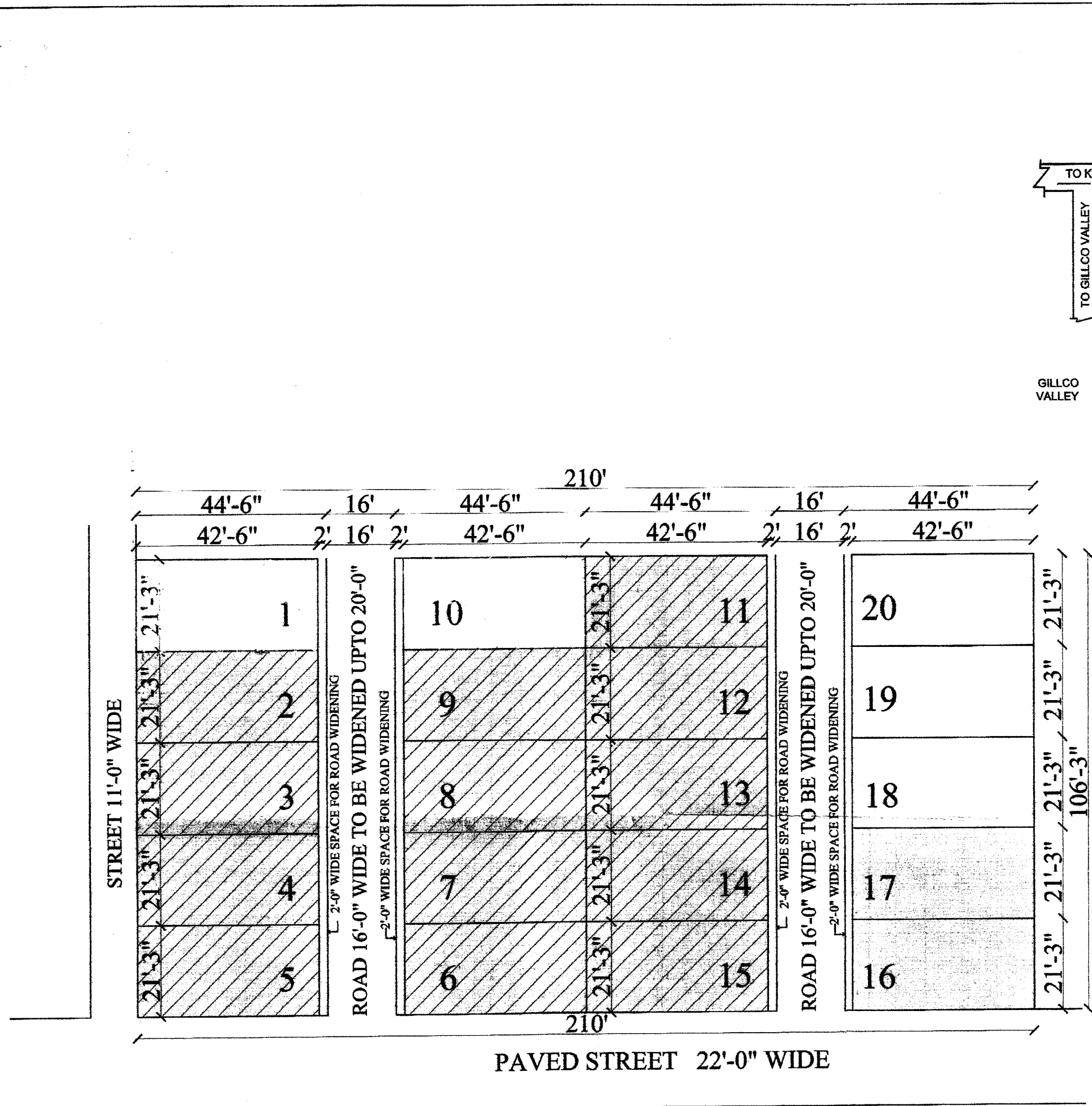

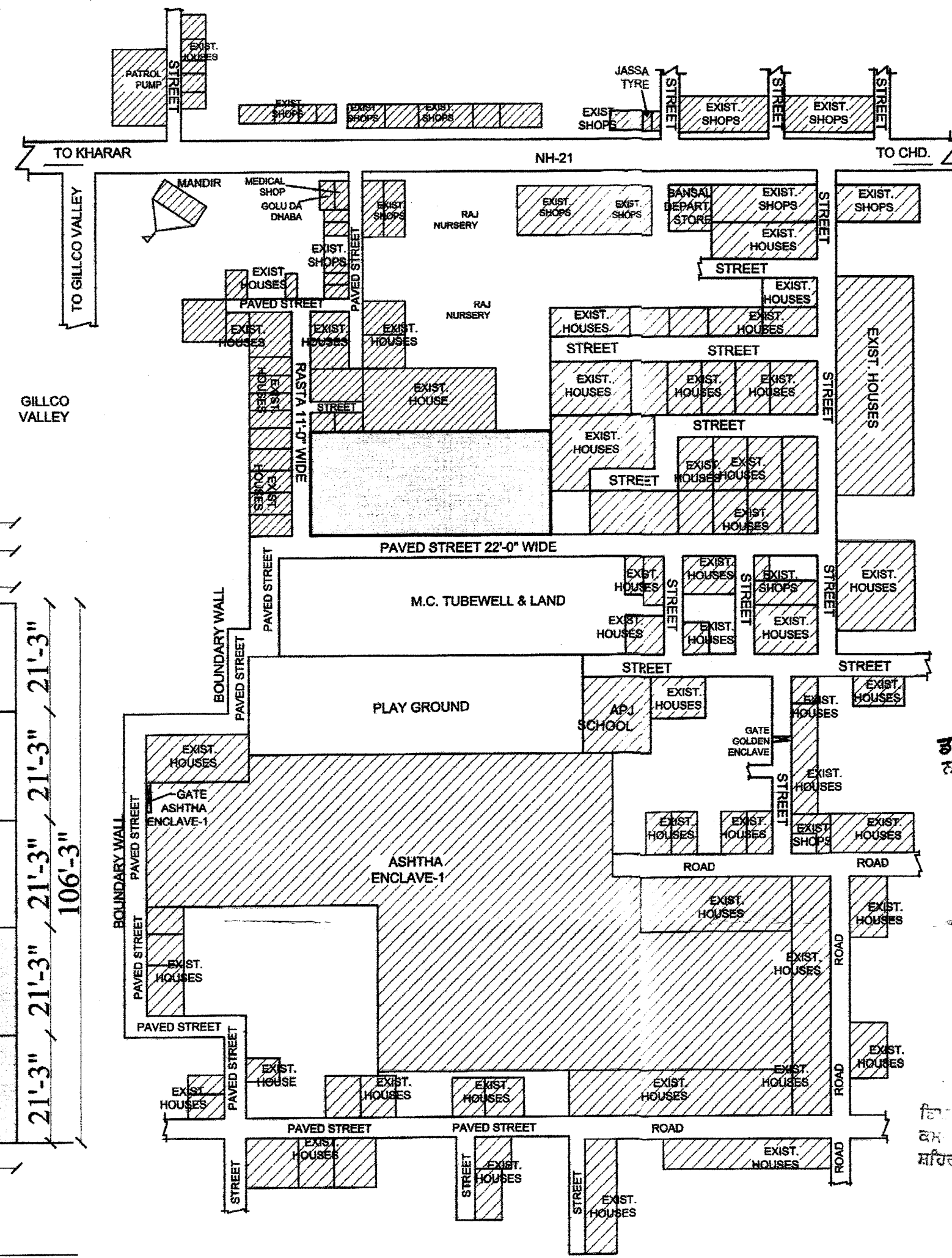
